**MOTION OF BIGGER PIE FORUM, LLC TO INTERVENE**

Bigger Pie Forum, LLC ("Bigger Pie"), pursuant to Rule 6.121 of the Mississippi Public Service Commission's Public Utility Rules of Practice and Procedure, files this Motion to Intervene in the above styled and numbered docket and hereby requests an order from the Commission granting Bigger Pie's authority to intervene in this docket. In support of the Motion Bigger Pie would show:

1. Bigger Pie, a Mississippi LLC, is headquartered at 750 Woodlands Parkway, Suite 201, Ridgeland, Mississippi 39157. Bigger Pie's mission is to research and share information that fosters greater economic freedom, economic growth and individual responsibility in Mississippi. Bigger Pie focuses on Education, Energy, Environment, Health Care, Federal Government and Agencies, Mississippi State Government & Agencies, and Regulatory Abuses and Reforms. Bigger Pie reports on and publishes articles concerning Mississippi's education, economy and government agencies, including the Mississippi Public Service Commission at [www.biggerpieforum.org](http://www.biggerpieforum.org)
2. BPF believes the cost of electricity is a vital component in the ability of many business owners to experience greater economic freedom by starting and/or growing their enterprises. For that reason, Bigger Pie has been actively engaged since 2010 in studying, commenting on, and educating the public about the Kemper County Power Plant, including the processes involved in each stage of its development and in the

Commission's consideration of regulatory dockets involving the Kemper plant.

Bigger Pie's early and consistent concerns about the Kemper project proved to be accurate and valid. Bigger Pie believes it can likewise offer valuable ideas for reforming the process of providing the public with safe, reliable, and affordable power. Bigger Pie is also equipped to offer unique perspectives on the suggestions of others who are likely to be parties to the Integrated Resource Planning (IRP) process now under consideration by the PSC.

Bigger Pie and its readers have a substantial interest in the outcome of this proceeding, and in the provision of suggestions relating to an Integrated Resource Planning Rule, and therefore request permission to intervene in this Docket. Bigger Pie's request is filed timely pursuant to the Procedural Rules.



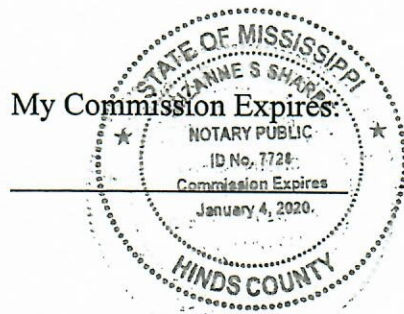
